****Small premises definitions**

Animal Boarding – 6 or fewer animals kept

Pet Shops – “*hobby sales*” with 10 or less animals (200 fish) for sale at one time

Dog Breeding - 6 or less *breeding bitches* (NB – breeding bitch numbers include all bitches at the premises able to be breed from)

Dangerous Wild Animals – *one animal type only, Category ‘3’ (least risk) or category ‘2’ where domestic to UK or regularly farmed (Secretary of State’s Standards of Modern Zoo Practice)*

Performing Animals Registration - *one animal type, Category ‘3’ (least risk) or category ‘2’ where domestic to UK or regularly farmed (Secretary of State’s Standards of Modern Zoo Practice)*

Riding Establishments – 6 or fewer horses

Zoo Licence – S14 dispensation in place

E-mail and phone advice included in overall fee. Advisory visits charged per hour or part thereof, including travel

Alternate vet – where non-standard vet requested by applicant
