



NOTICE OF CONFIRMATION OF A PUBLIC PATH ORDER

TOWN & COUNTRY PLANNING ACT 1990 **SECTION 257**

TORFAEN COUNTY BOROUGH COUNCIL

DIVERSION OF PUBLIC FOOTPATH NO. 19 CWMBRAN (PART) AT UPLANDS FARM, PONTNEWYDD, CWMBRAN

On 7th January 2026 Torfaen County Borough Council Confirmed the above Order.

The effect of the Order as Confirmed will be to divert a section of Public Footpath No. 19, north of Uplands Farm, Pontnewydd in the Community of Cwmbran which commences at its junction with Public Footpath No 15 (GR ST 2877 9786), south of Old Bevans Lane. It then proceeds in a westerly direction for 125 metres or thereabouts, a southerly direction for 35 metres or thereabouts then a westerly direction for 267 metres or thereabouts to its junction with Public Footpath No 20 and Public Footpath No 22 at GR ST 2836 9784. The total length of the path to be diverted is 302 metres or thereabouts and is shown on the Order Map as a bold black line from A – B. The path has a natural surface.

An alternative route will be created which will commence at its junction with Footpath 15 Cwmbran (GR ST 2877 9786), south of Old Bevans Lane. It will proceed in a west-north-westerly direction for 241 metres where it joins with Public Footpath No. 20 (GR ST 2843 9798). The length of the alternative route is approximately 210 metres and is shown on the Order Map as a dashed black line from C – D. The new footpath will have a hoggin surface and will be 2 metres wide.

The Order comes into force on 7th January 2026 but if any person aggrieved by the Order desires to question its validity or that of any provision contained in it on the ground that it is not within the powers of the above Act, or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the Confirmation of the Order, he or she may apply to the high Court for any of these purposes under Section 287 of the Town and Country Planning Act 1990 within 6 weeks from the date on which notice is first published as required by paragraph 7 of Schedule 14 to that Act.

DARGYFEIRIO LLWYBR TROED CYHOEDDUS RHIF 19 CWMBRÂN (RHANNOL) **YN UPLANDS FARM, PONTNEWYDD, CWMBRÂN**

Ar 7 Ionawr 2026 cadarnhaodd Cyngor Bwrdeistref Sirol Torfaen y Gorchymyn uchod.

Effaith y Gorchymyn fel y'i Cadarnhawyd bydd dargyfeirio rhan o Llwybr Troed Cyhoeddus Rhif 19, i'r gogledd o Fferm Uplands, Pontnewydd yng Nghymuned Cwmbrân sy'n dechrau wrth ei gyffordd â Llwybr Troed Cyhoeddus Rhif 15 (GR ST 2877 9786), i'r de o Old Bevans Lane. Yna mae'n mynd ymlaen i gyfeiriad y gorllewin am tua 125 metr, i gyfeiriad y de am tua 35 metr yna i gyfeiriad y gorllewin am tua 267 metr i'w gyffordd â Llwybr Troed Cyhoeddus Rhif 20 a Llwybr Troed Cyhoeddus Rhif 22 yn GR ST 2836 9784. Cyfanswm hyd y llwybr bydd yn cael ei ddargyfeirio yw tua 302 metr a gellir ei weld ar Fap y Gorchymyn mewn llinell ddu fras rhwng A a B. Mae gan y llwybr arwyneb naturiol.

Bydd llwybr amgen yn cael ei greu a fydd yn dechrau wrth ei gyffordd â Llwybr Troed 15 Cwmbrân (GR ST 2877 9786), i'r de o Old Bevans Lane. Bydd yn mynd ymlaen i gyfeiriad y gorllewin-gogledd-orllewin am 241 metr lle mae'n ymuno â Llwybr Troed Cyhoeddus Rhif 20 (GR ST 2843 9798). Mae hyd y llwybr amgen tua 210 metr a gellir ei weld ar Fap y Gorchymyn mewn llinell doredig ddu rhwng C a D. Bydd gan y llwybr troed newydd arwyneb graean, 2 fetr o led.

Daw'r Gorchymyn i rym ar 7 Ionawr 2026 ond os yw'r Gorchymyn yn digio unrhyw unigolyn a hoffai amau ei ddilysrwydd, neu ddilysrwydd unrhyw ddarpariaeth ynddo, ar y sail nad yw o fewn pwerau'r Ddeddf uchod, neu unrhyw reoliad a wnaed dan y Ddeddf, nad yw wedi cydymffurfio ag e mewn perthynas â Chadarnhau'r Gorchymyn, gall ef neu hi wneud cais i'r Uchel Lys ar sail unrhyw rhai o'r dibenion hyn, dan Adran 287 Deddf Cynllunio Gwlad a Thref 1990, o fewn 6 wythnos o ddyddiad cyhoeddi'r hysbysiad am y tro cyntaf, yn unol â pharagraff 7, Atodlen 14 y Ddeddf honno.
