4) Why does the Council process your personal data?

Necessary to meet the contractual obligations entered into by the person/citizen

The Council needs to process data to be able to provide a service to meet you and your family's individual needs e.g. administering funding for the Assisted Places.

By collecting your data it enhances the ability of Torfaen County Borough Council to co-ordinate support across agencies to provide a more seamless response to your needs and ensures that you benefit from the range of interventions and services provided.

Your data is also used to report on the service provision to relevant stakeholders such as Torfaen County Borough Council and Welsh Government. In reporting on the service provision, individual data is anonymised.

5) Special categories of personal data:

Do we collect special categories of data?

6) Who has access to your data?

The Council may share your data with relevant third parties internally and with other relevant professionals. This includes staff in Early Years Education Service, Aneurin Bevan Health Board and Childcare Settings.

7) How does the Council protect data?

The Council takes the security of your data seriously. The Council has internal policies in place to ensure the data it processes is not lost, accidentally destroyed, misused or disclosed. Furthermore data is not accessed by employees except in the performance of their duties. The policies that ensures this are the Data Protection Policy, amongst others.

Where the Council engages third parties to process personal data on its behalf, they do so on the basis of written instructions. These third parties are also under a duty of confidentiality and are obliged to implement appropriate measures to ensure the security of data.

8) How long does the Council keep your data?

The Council will hold your personal data only for the period that is necessary and will follow organisational and Local Authority standards in this area. We will keep your information in line with our Local Authority retention schedules.

We will keep your information for 7 years

9) Are we making automated decisions/profiling with your data?

Your rights

You have a number of rights you can exercise:

- access and obtain a copy of your data on request
- require the Council to change incorrect or incomplete data
- under certain circumstances you can require the Council to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing
- to know the period of time that the data will be stored for
- the right to data portability
- the right to withdraw your consent at any time
- the right to lodge a complaint with a supervisory authority (Information Commissioners Office)
- the consequences of if you fail to provide data to the Council
- the existence of and automated decision-making, including profiling and the consequences of this for you.
