HYSBYSIR TRWY HYN fod Cyngor Bwrdeistref Sirol Torfaen (a elwir ar ôl hyn "y Cyngor"), wrth arfer ei bwerau o dan y Ddeddf Rheoleiddio Traffig Ffyrdd 1984, fel y'i diwygiwyd gan Adran 1 Deddf Rheoleiddio Traffig Ffyrdd (Digwyddiadau Arbennig) 1994 a gyda chaniatâd Llywodraeth Cymru, wedi gwneud Gorchymyn yn gwahardd ac yn cyfyngu ar y defnydd o rai heolydd a chyffyrdd penodol gan gerbydau, marchogion, ceffylau, cerbydau a dynnir gan geffylau, a seiclwyr nad ydynt yn rhan o'r digwyddiad, er mwyn galluogi darn Torfaen o ras y Tour of Britain, Cymal 5 i fynd ar hyd y ffordd a bennir ac i sicrhau diogelwch pawb sy'n cymryd rhan yn y digwyddiad ddydd Sadwrn, 6^{ed} Medi 2025.

Bydd y digwyddiad yn gofyn am gau heolydd a chyffyrdd yn ogystal â chyfyngu ar a gohirio nifer o Orchmynion Rheoleiddio Traffig. Bydd pob darpariaeth yn y Gorchymyn yn dod i rym ddydd Sadwrn, 6^{ed} Medi 2025 yn ystod yr amserau a bennir yn Atodlenni'r Gorchymyn. Mae'r heolydd sydd i'w cau a'r heolydd sy'n destun cyfyngiadau a holl ddarpariaethau'r Gorchymyn yn Atodlenni'r Gorchymyn.

Oherwydd hyd y ffordd a natur y cau, nid yw'r Cyngor yn ystyried ei fod yn ymarferol argymell ffyrdd amgen ar gyfer traffig. Serch hynny, mae trefnydd y digwyddiad wedi nodi nifer o Bwyntiau Mynediad Lleol Mewn Argyfwng (ELAP) ar hyd prif ffordd y ras ble mae modd rheoli mynediad gan gerbydau ar draws yr heol mewn amgylchiadau argyfwng neu eithriadol yn unig.

Ni fydd y cyfyngiadau'n berthnasol i gerbydau sy'n cael eu defnyddio mewn cysylltiad â'r dywededig ddigwyddiad, gan gynnwys y rheiny a ddefnyddir at ddibenion stiwardio, rheoli tyrfaoedd a rheoli traffig, neu i unrhyw beth a wneir dan gyfarwyddyd neu drwy ganiatâd Heddwas mewn gwisg Heddlu, marsial traffig, swyddog dynodedig, trefnydd y digwyddiad neu unrhyw swyddog arall a awdurdodir ar gyfer rheolaeth a gweithredu'r digwyddiad, neu'n unol ag unrhyw arwydd a osodir gan Gyngor Bwrdeistref Sirol Torfaen.

Cedwir mynediad ar ddibenion yr Heddlu, y Gwasanaeth Tân a'r Gwasanaeth Ambiwlans ac i sefydliadau sy'n gyfrifol am ymdrin â cholli cyflenwadau nwy, trydan, dwr neu gyfathrebiadau electronig, i eiddo yn yr ardal ac ar gyfer tynnu ymaith unrhyw rwystr i draffig sy'n cymryd rhan yn y digwyddiad.

Awdurdodir tynnu i ffwrdd unrhyw gerbyd yr ystyrir ei fod yn rhwystro taith y ras, yn achosi niwsans a/neu rwystr ar yr heolydd, cyffyrdd neu ymylon ffyrdd a bennir yn Atodlenni'r Gorchymyn, gan yr Heddlu trwy eu contractwyr cymeradwy o dan eu dyletswyddau a'u grymoedd statudol er mwyn hwyluso cynnal y digwyddiad.

TEMPORARY TRAFFIC REGULATION ORDER 2025

NOTICE IS HEREBY GIVEN that Torfaen County Borough Council (hereinafter referred to as the Council) in exercise of their powers under the Road Traffic Regulation Act 1984, as amended by Section 1 of the Road Traffic Regulation (Special Events) Act 1994 and with the consent of the Welsh Government, has made an Order prohibiting and restricting the use of certain roads and road junctions by vehicles, horse riders, horses, horse-drawn vehicles and non-event cyclists to enable the Torfaen section of the Tour of Britain, Stage 5 to proceed along the specified route and ensure the safety of all participants in the event on Saturday 6th September 2025.

The event will require the closure of roads and road junctions as well as the restriction and suspension of a number of Traffic Regulation Orders. All provisions of the Order will come into effect on Saturday 6th September 2025 during the times specified in the Schedules to the Order. The roads to be closed and the roads subject to restrictions and all other provision of the Order are set out in the Schedules to the Order.

Such is the length of the route and nature of the closure, the Council does not consider it practicable to recommend alternative routes for traffic. However, the event organiser has identified a number of Emergency Local Access Points (ELAP's) along the main race route where vehicular access across the road can be managed in emergency or exceptional situations only.

The restrictions will not apply to vehicles being used in connection with the said event, including those used for stewarding, crowd management and traffic management purposes, or to anything undertaken on the direction of or with the permission of a Police Constable in uniform, a traffic marshal, designated officer, event organiser or any other official so authorised in the control and operation of the event, or in accordance with any sign placed by Torfaen County Borough Council.

Emergency access will be maintained for Police, Fire Brigade and Ambulance purposes and for organisations responsible for dealing with the loss of supplies of gas, electricity, water or electronic communications, to premises in the area and for the removal of any obstruction to traffic participating in the event.

Any vehicle deemed to be hindering the passage of the race, causing a nuisance and/or obstruction on the roads, road junctions or verges specified in the Schedules to the Order shall be authorised by the Police to be removed by its approved contractor under its statutory duties and powers in order to facilitate the holding of the event.

TEMPORARY TRAFFIC REGULATION ORDER 2025

SATURDAY 6TH SEPTEMBER 2025

WHEREAS the Torfaen County Borough Council (hereinafter referred to as "the Council") being the highway Authority for Torfaen is satisfied that vehicles, horse riders, horses, horse-drawn vehicles and non-event cyclists should be prohibited and restricted on the roads specified in columns 2 and 3 of the Schedules attached hereto on Saturday 6th September 2025 between those hours as appear in column 4 of the said Schedules.

AND WHEREAS the prohibitions and restrictions are necessary to facilitate the holding of the Tour of Britain 2025.

NOW THEREFORE the Council, acting with the consent of the Welsh Government and after consulting with the police and in exercise of its powers under S.16A of the Road Traffic Regulation Act 1984 (as amended) (hereinafter referred to as "the Act") and all other enabling powers, hereby makes the following Order prohibiting and restricting the use of certain roads and road junctions by vehicles, horse riders, horses, horse-drawn vehicles and non-event cyclists to facilitate the holding of the Tour of Britain on Saturday 6th September 2025.

In this Order the following expressions have the meanings hereby respectively assigned to them:-

"Relevant event" means the Tour of Britain 2025

"Council" means Torfaen County Borough Council

"Act" means the Road Traffic Regulation Act 1984 as amended by Section 1 of the Road Traffic Regulation Act 1994

"Designated officer" means an officer appointed by the Council in respect of traffic management or similar duties necessary as part of the Tour of Britain 2025

"Police vehicle" has the same meaning as in Schedule 1 of the Traffic Signs Regulations and General Directions 2016 (SI 2016 No. 362)

- Subject to Article 3, all those lengths of road specified in columns 2 and 3 of Schedules 1 and 2 to this Order shall be closed to all vehicles during the period of the closure specified in column 4 of the said Schedules and no traffic as aforesaid shall enter, wait, leave or pass along over the said lengths of road during the said period of closure.
- 2. Except upon the direction of or with the permission of a Police Constable, Police Community Support Officer, designated officer, event organiser or any person in connection with the relevant event, no person shall cause or permit any horse riders, horses, horse-drawn vehicles and non-event cyclists to proceed in the lengths of road specified in columns 2 and 3 of Schedules 1 and 2 to this Order.
- 3. Nothing in Article 1 of this Order shall render it unlawful to cause or permit any vehicle to enter, wait, leave or pass along the lengths of road to which those Articles apply if it is necessary to do so to enable:-
 - (i) any vehicle being used in connection with the relevant event including those used for stewarding, crowd management and traffic management purposes, or
 - (ii) any vehicle officially accredited to the relevant event and which displays the appropriate accreditation operating in connection with the relevant event, or
 - (iii) any vehicle being used on the direction of or with the permission of a police constable in uniform or a traffic marshal, designated officer or any other official so authorised in the control and operation of the relevant event or in accordance with any sign placed by the Council or approved traffic management specialist acting on behalf of the event organiser, or
 - (iv) any vehicle being used in connection with the relevant event by a designated officer
 - (v) any vehicle being used for the removal of any vehicle deemed to be hindering the passage of the race, causing a nuisance and/or obstruction on the roads or road junctions, specified in the Schedules to this Order, or
 - (vi) any vehicle to be used for police, fire brigade or ambulance purposes in cases of emergency, or
 - (vii) any vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in an emergency, in connection with any building operation or demolition, the maintenance, improvement or reconstruction of the road or the laying, erection, alteration or repair in, or in land adjacent to the road of any sewer or of any main, pipe, wire or cable or any apparatus for the supply of gas, water or electricity or of

any electronic communications apparatus as defined in Schedule 3A to the Communications Act 2003.

- 4. All provisions relating to speed limits either by Order or by virtue of street lighting (Restricted Roads) are hereby suspended on the roads specified in Schedule 3 in so far as they relate to any vehicle used in conjunction with and for the duration of the relevant event.
- 5. Any vehicle deemed to be hindering the passage of the race, causing a nuisance and/or obstruction on the roads; or road junctions specified in the Schedules to this Order shall be authorised by the Police to be removed by its approved contractor under its statutory duties and powers in order to facilitate the holding of the relevant event.
- 6. The Council is satisfied that, in order to avoid danger to persons or other traffic using the roads to which this Order relates, or for preventing the likelihood of any such danger arising, or for facilitating the passage of vehicular traffic on the roads, vehicular access to premises situated in the Schedules to this Order or accessible only therefrom may be restricted for the duration of the Order save as provided in Article 3 of this Order.
- 7. The Council is also satisfied, in accordance with Section 16A (3) of the Act, that the event to which this Order relates cannot be held otherwise than on a road. Such is the length of the route and the nature of the closure, the Council does not consider it practical to recommend alternative routes for traffic.
- 8. Access for pedestrians to premises situated on or adjacent to any road to which the Order relates will not be prevented.
- 9. In the event of a delay being caused by whatever reason, the timings within the Schedules can be extended to allow the event to continue.
- 10. The Order shall come into operation on 6th September 2025 and may be cited as the Torfaen County Borough Council (Tour of Britain 2025) Temporary Traffic Regulation Order 2025.
